ORDINANCE NO. 523-2010:AN ORDINANCE BY THE COUNCIL OF THE VILLAGE OF PANDORA ESTABLISHING NO PARKING ZONE ON NORTH JEFFERSON STREET IN THE VILLAGE OF PANDORA, PUTNAM COUNTY, OHIO. The Village Administrator reported on the following: 1) The steering and brakes went out on the red truck.
