The Mayor, Village Administrator, and several council members looked at the fire station addition after the meeting on March 27, 2012. Mayor Schlumbohm stated the construction concerns raised by the Fire Chief on March 27th did not seem to adversely affect the integrity of this construction and thus final payment shall be made to said contractor.

The Village Administrator reported on the following: 1) Roof on the maintenance building next to the Village Administrator's office is in need of repair. The metal is thin and does leak at several locations inside the building. After some discussion it was the consensus of the Council to apply fiber paint to said roof. 2) Discussion was had as to 2012 contributions to the Putnam CIC. It was the consensus of the Council to contribute \$1,000 per quarter. 3) Recommendation to hire Zach Niese for Summer help. 4) Discussion was had as to flowers along Main Street as in previous years. It was recommended to contact the Pandora Chamber of Commerce if they would be willing to purchase the flowers for the flower pots to be placed along Main Street. The Village would be willing to purchase flowers in front of the City Building and the planter along the Municipal Parking Lot for a project of the local Girl Scout troop. 5) Discussion was had as to repairing the "dips" on Basinger Road, south of the ADS Building to the south corporation limit. Mr. Schneck will obtain a quote from Ward Construction. 6) There are several areas of curbing on State Route 12 as well as a "dip" on the north side of State Route 12 between North High Street and North Jefferson Street for possible repairs. Mr. Schneck will also obtain quotes as to these repairs.

Discussion was had as to the Road 5 extension project. Mayor Schlumbohm stated prior to inviting the village residents along Road 5 to a council meeting, to invite the Putnam County Engineers at a council meeting, April 24, 2012 if possible, to discuss in further detail the proposal of widening the turning radius at the intersection of Road 5 and State Route 12. Once the Putnam County Engineers have met with the village council, then the village council will invite the village residents along Road 5 to a council meeting to discuss this issue. Contact will be made to invite the Putnam County Engineers to attend the April 24, 2012 council meeting.

Motion was made by Mr. Hall, seconded by Mr. Fricke to excuse Mr. Vance and Mr. Swary from this meeting. Voting: All Yea.
