Village Administrator, Stanley Schneck, stated as soon as the weather breaks, the concrete work for the addition to the fire station will begin. Mr. Kinsinger stated the Fire Department is not planning on any major expenditures for the year.

The Village Administrator reported on the matter of Ordinance No. 532-2011-Flood Damage Reduction. Since the adoption of this ordinance it has come to our attention there is one residence which is in the flood plain and is in non-compliance with the flood program. Discussion was had as to this matter. There is a possibility this residence could be exempt from this infraction if this residence is above the minimum flood elevation. It was the consensus of the Council for the Village Administrator to contact the owners of this property and explain the situation. The Village will have this property surveyed as to elevation and will incur the costs of said survey.

Village Solicitor, Scott Basinger, stated there was a hearing on Tuesday, January 17, 2012 in the Putnam Court of Common Pleas as to the Peth property. The results of this hearing was this property will be scheduled for Sheriff's sale or the Judge will force the issue for the property to be sold.

At present they have approximately 20 employees. 3) The village spent approximately \$275,000 in capital expenditures: St. John Mennonite Church project-12"water line in the Industrial Park and forced main sewer line to the church; purchase of new truck; street and gutter repairs; EMS building repairs and handicap parking at the Community Center.
