The Pandora Village Council met in Regular Session on Tuesday, September 27, 2016 at 7:00 PM at the Municipal Building with Mayor, John Schlumbohm, presiding.

Members Present: Burkholder, Eisenbach, Liechty, Klingler, Tadena, Braidíc Members Absent: None

The meeting was opened with the Pledge of Allegiance.

Motion was made by Mr. Tadena, seconded by Mrs. Braidic, to approve the September 13, 2016 Minutes. Voting: All Yea.

Motion was made by Mr. Eisenbach, seconded by Mr.Burkholder, to approve the bills as presented: Total non-payroll of \$7,616.01 and payroll of \$13,196.90 for a total of \$20,812.91. Voting: All Yea.

Resolution No. 2016-648: RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR. Motion was made by Mr. Liechty, seconded by Mr. Tadena, to adopt Resolution No. 2016-648 as read for its third and final reading: Voting: All Yea.

Bruce and Danna Warren, residents of Pandora, were present to address Council regarding Ordinance No. 524-2010. In June of 2016 their home had fire damage and to date has not been fully repaired. Ordinance No. 524-2010 provides that in certain fire losses a portion of insurance proceeds shall be transferred by the insurance company to the municipality where the fire occurred as security against the total costs of removing, repairing, or securing the damaged building. Mr. and Mrs. Warren questioned Council to determine if their fire damage fell under this Ordinance. Motion was made by Mr. Liechty, seconded by Mr. Tadena that Ordinance No. 524-2010 does not apply as the fire damage at this property did not result in a total loss and therefore the escrow provision of funds, per Ordinance, is not required. Voting: All Yea.

Council reviewed and discussed the street repair quote from Ward Construction Co. Motion was made by Mr. Burkholder, seconded by Mr. Liechty to approve Ward Construction to do the following repairs per the attached quote; 1a., 2, 3, 4, 5, 6, 7a., 10b., 12, 13, 14 at a total cost of \$35,075.00. Voting: Burkholder-Aye, Eisenbach-Nay, Klingler-Aye, Liechty-Aye, Braidic-Nay, Tadena-Nay. Motion failed due to lack of majority. Mayor Schlumbohhm abstained from breaking the tie due to a conflict of interest.

Motion was made by Mr. Klingler, seconded by Mr. Tadena, to approve Ward Construction to do the following repairs per the attached quote; 1a., 2, 3, 4, 5, 6, 7a., 10b., 12, 13, 14 at a total cost of \$35,075.00 and to authorize the Village Administrator to obtain a second quote for items 9 and 10a which would need to come in at a lower cost and be able to be completed this year. Voting: Burkholder-Nay, Eisenbach-Aye, Klingler-Aye, Liechty-Aye, Braidic-Aye, Tadena-Aye.

Village Administrator, Rick Morrison reported on the following:
1) High service pump #3 has been reinstalled at the water plant.
2)BO-DEC Inc. will be doing roof repairs at the water plant and city building. Both roofs will have a 10 year warranty and the total cost will be \$8,440.00. 3) Smoke testing will be finished on September 28th. 4) James Mchaffie, Village Administrator from Bluffton has contacted Village Administrators from surrounding communities to get their interest in meeting bi-monthly to share their knowledge and experience with each other. There were nine in attendance at the first meeting and a lot of topics were discussed. These meetings will be very beneficial.

Police Chief, Scott Stant informed Council that he was contacted regarding the need for a street light in the Community Center Parking Lot. Mr. Tadena will look into this.
