1. Remittance copy of this reconciliation must be filed with the Income Tax Department of Pandora, OH on or before February 28, unless you discontinued having employees before December 31, in which case it must be filed within thirty days after the last payment of wages. This form must be accompanied by the department's copy of Federal Form W-2 for each employee from whom tax has been withheld during the past year.

2. An adding machine tape or some other type of list showing the total amount of Pandora tax withheld as indicated by Federal Form W-2 should be attached. The total should be entered on Line 2 on the face of this form and should be in agreement with the amount shown on Line 4. Any discrepancy between the two amounts must be fully explained in an attached statement.

3. Copies of all 1099s issued by a business located or doing work within the Village of Pandora must be submitted to our office in addition to copies of W-2s.
